## Parks

## **Barnet Playing Fields**

- This park has a Children's Play Area with 5 full size and five 7-a-side football pitches (only booked during the Summer) and a Basketball Hoop

## **Bittacy Hill Park**

- This park currently has a Children's Play Area and Tennis Courts

## **Halliwick Park**

- This park has a Children's Play Area and Tennis Courts

## **New Southgate**

 This part has a range of facilities having 1x Junior and 1x 7-a-side winter Football pitches. It also has 2 Cricket tables (currently out of use) a Children's Play Area and Tennis Courts

## **Stonegrove Park**

- This park presently has a Children's Play Area. It also facilitates Tennis Courts

## **Victoria Recreation Ground**

- Victoria Recreation ground currently has 6 Bowls Greens and 2 full sized winter football pitches. This park also facilitates a Children's Play Area with Basketball Court and Tennis Courts

## West Hendon

West Hendon currently facilities two 7-a-side, one Junior and nine full sized football

pitches, it also has a Cricket table, 6 Bowls Greens a Children's Play Area, and Tennis Courts.

## **Proposed Terms**

- a) Pitch licenses are available with a term of up to 2 years with an option for a 1 year extension
- b) General Public Liability Insurance Requirement of £5,000,000. Proof will need to be provided before trading commences.
- c) The licensee will be liable for any damage caused to the council's property
- d) Licensees must prove registration with Environmental Health Section and have undergone an appropriate level of food hygiene training.
- e) The licensee will be required to follow the health and safety requirements listed below
- f) Payment of £250 administration fee for the preparation and agreement of the licence
- g) The location of the pitch to be agreed prior to commencement of the licence. The council will require thought to vary the pitch within the park giving reasonable notice

## Health and safety requirements


- We require licensees to have full approval and registration with Barnet Council's Environmental Health Department. For those not currently registered, registration needs to be done 28 days before licensee intends to trade. Registration can be done online at https://www.gov.uk/apply-for-a-licence/food-premisesregistration/barnet/apply-1 or call on 020 8359 7995 for more information.
- II. Premises and surrounding area to be cleaned daily of any rubbish, oil and grease from vehicles or generators
- III. The licensees to have appropriate facilities available to enable staff to maintain adequate personal hygiene. This will include facilities for hand washing & WC provision
- IV. Food contact surfaces must be in a sound condition and easy to clean & disinfect
- V. Provision for washing work utensils and equipment
- VI. If food is to be washed, adequate provision is to be made for this to be done hygienically

- VII. Adequate supply of hot and cold potable water must be available
- VIII. Arrangements for the proper disposal of waste, including waste water are to be agreed with the licensors and maintained by the licensee
- IX. Adequate facilities and arrangements for maintaining and monitoring suitable food temperature conditions are to be provided by the licensee
- X. Food is to be displayed for sale avoiding its contamination.
