Improvements to the local area

- As well as possible changes to the road layout, the Council is considering improvements to pedestrian areas on Oakleigh Road
- Local improvements such as safety railings, underpass improvements, and enhancements to the bus stop could be part of the scheme
- Your views will help to identify potential improvements.

Assessment work

- The final proposals will only be submitted once the appropriate assessments have been carried out, including:
- Ongoing environmental studies
- Traffic assessments consisting of traffic counts and junction surveys
- A full acoustic impact assessment
- A Land and Visual Impact Assessment (LVIA).



Noise and visual

- Based on the results of the acoustic assessment, options to provide noise mitigation will be considered, including screening and landscaping
- As part of its plans, the Council is proposing to plant trees to provide natural visual screening
- There is also the potential to put up a noise abatement screen
- All of the Council's waste and recycling collection vehicles are fitted with 'white noise' reversing signals
- The refuse and recycling collection vehicles will typically operate between 6:20am and 4pm Monday to Friday, and between 6:20am and 2pm on Saturdays.

Traffic and access

- A Traffic Management Plan (TMP) will be put in place to minimise the impact of vehicles using the site
- Improvements to the road layout on Oakleigh Road South will be considered – early plans are available to view
- A fleet of 46 household waste and recycling collection vehicles will use the depot as a base
- These vehicles will generate approximately 127 additional vehicle movements, which is just under 1% of the existing traffic flow along Oakleigh Road on a typical weekday
- Staff vehicles, the Council's winter gritting fleet and other HGVs will also visit the depot
- Drivers will be briefed on best practice behaviour and instructed to follow the TMP.

Odour and litter

- Only dry recyclables and food waste will be brought to the site. There will be no residual waste (black bin) material
- All material will be unloaded into a covered area to avoid wind-blown litter
- Food waste will be brought to the site and stored in covered containers to limit smell. It will be removed from the site every day
- Recyclable materials will be taken away in covered vehicles to limit litter
- No recyclable material or food waste will be left on site overnight
- The site will be cleaned down at the end of each day so there is no loose material lying about.
