Summary of BSCB Board Meeting on 20th March 2013

• MASH (Multi-agency Safeguarding Hub) — Phase 1 (co-location of the council and the police public protection desk) has been established. The development of Phase 2 involving co-location of all partner agencies including health, education and housing is progressing. There has been some delay in with securing the lease for the building for Phase 2. As soon as the lease is signed, partners will expedite the installation of their equipment to launch Phase 2.

- **Munro** Demonstrator—overall the work undertaken to integrate the Munro recommendations into ongoing practice has had a positive impact. The work which has been carried out so far is already achieving positive outcomes for children and young people in Barnet.
- Following their win, Youth Shield are currently in the process of recruiting new members and want to expand their training to the schools.
 They are looking to develop peer to peer training. They met with the Mayor and the Deputy Mayor has requested a copy of the consultations.
- SCIE—the findings from the full review that was undertaken were discussed and it was suggested that Champions be identified to look at the safeguarding across the partnerships in particular picking up on the five typology's identified within the report. This will be further discussed at the Board Review Day in May.
- E-Safety Group—received a proposal from Sharon Harrison who has agreed to get this group up and running.
- Section 11—the deadline for the returns has been extended to 19-04-13. If agencies cover other boroughs, they can send in the same return—there is no need to do separate ones for the individual boroughs.
- Safeguarding Performance Data—this dataset was reviewed at the meeting and further discussions will take place about particular areas at the Review Day in May.
- LSCB/MAPPA—all those present at the Board meeting agreed with the protocol and were happy to sign up to it. The only issue that arose is that there was no clarity as to which health services are involved. It was suggested that it should be changed from PCT to Health Care Trusts. Tim Beach said that he would feed this back to the London Board.
- City Safe Haven—Noelle Doona from Hendon School required some more support to progress this project. Several Board members agreed to assist and Noelle can be contacted at citysafe@hendonschool.co.uk or DoonaN@hendonschool.co.uk
- BSCB Budget—Tim Beach asked partner agencies to have discussions within their services and to inform him if they anticipate any problems with their contributions to the Board for 2013-2014.

New Working Together Guidance 2013

Briefing from London Safeguarding Children Board

Overview

The Government originally consulted on a suite of documents aimed at reforming the English child protection system in June 2012, cutting down more than 700 pages of existing guidance to just 68. The consultation process provoked a wide range of views from stakeholders, and the documents have undergone several revisions over the past 9 months. They have now been merged into one piece of statutory guidance, *Working Together to Safeguard Children 2013*, which makes several important changes to the existing safeguarding children framework.

The new guidance focuses strongly on legislative requirements, and removes large sections of non-statutory practice guidance. However, *Working Together 2013* is lengthier than the documents originally issued for consultation (now reaching 97 pages), and includes more detail on the roles and responsibilities of partner agencies such as health and the police. The guidance is clear that "safeguarding is everyone's responsibility", and other headlines include:

- The reinstatement of statutory timescales for assessing the needs of vulnerable children, which had been removed from the consultation documents;
- A removal of the distinction between initial and core assessments, replaced by ongoing, locally developed, assessments of need;
- A change in the governance arrangements for independent Chairs of local safeguarding children boards (LSCBs), who will now be appointed and held to account by the local authority Chief Executive rather than the Director of Children's Services:
- The establishment of a national panel to hold LSCB Chairs to account on whether serious case reviews should be carried out, which independent reviewers should be commissioned to lead the review, and to challenge any decision that the report should not be published;
- A strong reiteration of the government's intention that all serious case reviews should be published in full, and more detailed guidance on what this means in practice;
- A reversal of the consultation's proposal for all future serious case reviews to be undertaken using so called "systems methodology", with LSCBs instead free to use any model that is broadly in line with stated principles; and
- A requirement on LSCBs to develop a local framework for learning and improvement, including regular reviews of cases that may not meet the criteria for a full serious case review, as part of an ongoing process of learning and development.
