#### **Membership**

- 4. The Director of Children's Service (DCS) or his/her representative
- Only the 10 representatives may vote.
- The group will be chaired by the representative of the Director of Children's Service
- At least one member should also be a member of the Schools Forum
- Membership will cover all areas of the current providers of the free entitlement for 3 & 4 year olds:
- Members should represent a fair cross section of each of the 4 Learning Network Boards.
- Members should be nominated by their peers and may hold office for 2 years.
- Members of the Schools Forum may attend as observers if they are not members of the working group
- No substitutes will be allowed.

- The local authority will draw up the agenda in discussion with the DCS and the Chair of the Schools Forum
- Agendas may cover the following topics, plus any others relating to the provision and funding of the free entitlement:
  - Findings of pathfinder authorities
  - o The results of the Childcare Sufficiency Assessment
  - A consistent funding formula for all providers
  - Pupil data collections
  - Relative costs in different sectors
  - o In year adjustments to funding
  - Provision for deprivation
  - Special educational needs

o Distribution of funding for the extra 2½ hours and greater flexibility
